

## RULES OF CONDUCT

The following rules govern your rights to be at the Center and these activities are specifically prohibited at Irvine Company Retail Properties:

1. Carrying and/or open display of any firearm, BB gun, pellet gun, or air soft gun including rifles and pistols or replicas whether loaded or not.
2. Carrying and/or open display of a knife, or any weapon that could cause harm to others.
3. Possession, use or under the influence of marijuana, alcoholic beverages and/or any illegal or non-prescribed drug.
4. Running, shouting, horseplay, throwing of any objects: disorderly or disruptive conduct of any type.
5. Standing or walking in large groups that may restrict free passage on all walkways, doorways, or aisles within the center.
6. Use of loud or obscene language or gestures.
7. Any act which could result in harm to persons or property.
8. Any act defined by Federal, State, or local ordinance that constitutes an illegal act.
9. Tents, open flames, and/or BBQ's of any type, either inside the Center or its parking lots.
10. Curfew for all minors under 18 years of age is 10:00 pm unless a parent or guardian is present.
11. Commercial photography or video taping of any structure, location, or feature of the shopping center without prior permission from Irvine Company.
12. Bicycles, skateboards, skates, rollerblades, or scooters within the interior of the Center or parking areas.
13. Smoking of any kind including vapor products except in authorized areas.
14. Soliciting money or other contributions or donations, engaging in commercial activity or distributing advertising or promotional material of any kind, or offering samples of items which are sold, available for sale or available in exchange for a donation or contribution.
15. Expressive Activity (ex. Free Speech), unless permitted by, and in conformance with the Center's Rules for Public Use of the Common Areas and approved by center management.

## DRESS CODE

In order to maintain a pleasant and appealing environment for everyone, we ask that all visitors comply with the following rules:

1. Shirts and shoes or sandals must be worn at all times.
2. Wearing or displaying any obscene, profane, illegal item, or any item which is incompatible with a family-oriented shopping center is prohibited.
3. Visitors may not wear any item intended to demonstrate or convey membership in a group whose presence appears to create a threat to persons or property.
4. Items that could be used as weapons may not be worn or displayed.

Irvine Company Retail Properties and Security reserve the right to determine whether certain attire is incompatible with a family oriented shopping center. Visitors are asked to comply with the rules listed above and will be informed of the nature of the violation.

FAILURE TO COMPLY WITH ALL RULES OF CONDUCT OR DRESS CODE CAN RESULT IN AN ORDER TO LEAVE THE PROPERTY AND/OR RETENTION OF YOUR DEPOSIT. FAILURE TO COMPLY WITH AN ORDER TO LEAVE CAN RESULT IN A TRESPASS ARREST.
