### Upcoming Planning Commission Item:

**New Apartment Community (Tustin Legacy - Between Warner/Tustin Ranch Road, adjacent to Legacy Road):** On **January 14**, the Planning Commission will consider a request by The Irvine Company to construct a new 1,336 unit apartment community, including a publicly accessible park, cafe, open spaces, and pedestrian-friendly linkages to the Tustin Legacy area.
