General Application Information and Agreement



- All applications will be subject to committee approval.
- Upon approval of your application, you must submit all necessary certificates including your business license and sales permits. You must submit the documents within seven business days or your application will be voided and you must reapply.
- Booths are required to be open and staffed during event hours - no exceptions. Vendors will be required to stay until 2:00 PM the day of the event.
- Each vendor will be responsible for all cash sales at his/her booth. Please make your own arrangements for adequate change.
- You will sell only those items listed and approved on your application. Items not allowed to be sold: Real or toy weapons, drugs, alcohol, and food/drink. If you sell these you are at risk of not receiving a refund.
- Vehicles must follow all traffic regulations (traffic flow, parking, no parking areas, speed on site, etc.). Load in time for vendors is 8:00 AM - 9:00 AM. All cars must be removed from the area by 9:30 AM.
- Vehicles in violation of parking regulation will result in vehicle being towed away at owner’s expense. NO EXCEPTIONS.
- Vendors will receive a 10 x 10 space that includes one (1) table and two (2) chairs the day of the event. It is highly advised to bring your own canopy as it will be hot.
- Vendors must check in at Veterans Sports Park.
- Vendors will not be checked in before 8:00 AM NO EXCEPTIONS.
- THERE IS NO GUARANTEE OF SPACE REQUESTS.
