## Suspension from Program

- Failure to provide the necessary paperwork or falsification of paperwork may cause suspension from the program. We cannot serve children safely if we do not have accurate information.
- The program staff also reserves the right to suspend and/or withdraw participant(s) from the program due to the actions of their parents/guardians. Suspension and/or withdrawal may occur for any, but not limited to, the following reasons:
  - Inappropriate behavior towards program staff or other City employees, i.e. use of inappropriate language, being verbally, physically threatening, or intimidating, and any physical aggression and/or damage to property
  - Disregard or refusal to follow program policies or procedures
- If a child has a difficult time adjusting to the program, parents will be notified and solutions will be proposed and implemented. If the child's adjustment is not satisfactory for their benefit or for the safety of others, the Program Coordinator may request that the parent seek a different type of activity or program for the child.
- Refunds will be considered on a case-by-case basis with the Parks and Recreation Supervisor.

## Parent Handbook

### **Welcome**

Welcome to Tustin Summer Camp! We are looking forward to meeting you and your child and hope that we can help you both have a rewarding experience. The City of Tustin believes strongly that our community needs quality, recreational enrichment programming for school age children. The Parks and Recreation Department has implemented Camp Tustin with the purpose of enhancing the quality of life within our community.

### **Introduction**

Our team strongly encourages communication and teamwork to provide the best possible care for the children while also serving as a source of support, resources, and growth for each other and our families. We will make every effort to get to know your child. To keep you informed, we will share a weekly schedule of activities.

Parents can help us by:

- Getting to know your child's group leader, staff, and the camp Coordinator
- Keeping us informed
- Sending your child to camp with the proper clothing and supplies

### **Parent Checklist**

- Label any and all items that your child is bringing to camp
  - Close-toed shoes
  - Water bottle
  - Sunscreen
  - Lunch and two (2) snacks (camp will not provide lunch)
  - Medication, if applicable
- Check the front desk daily for supplemental information and announcements

### **General Guidelines**

Our trained staff members, certified in CPR and First Aid, provide daily activities with a 10:1 ratio. Daily activities are scheduled Monday through Friday, from 8:00 am to 5:00 pm, rain or shine.

### **Registration Information**

- Advanced registration is required. Please see the Tustin Today for updates.
- Registration includes weekly excursion

### **Refund and Transfer Policy for Fee-Based Camp**

- Requests for refunds must be submitted to [tprd@tustinca.org](mailto:tprd@tustinca.org) or 714.573.3326 a minimum of five (5) days prior to the first day of the camp week
- A \$25 withdrawal fee will apply per child, per week, for Camp Tustin and Teen Camp.
- A \$15 withdrawal fee will apply per week for Little Folks Camp. Any withdrawal requests received fewer than five (5) days prior to the start of the second day of camp will receive a 50% refund of the camp fee per week per child

- No refunds will be honored after the start of the second day of camp
- Transfers are not permitted

### **Arrival and Departure Procedures**

- Upon arrival, children must be signed-in by an adult
- Upon pick up, children must be signed out by an authorized adult
- Children must be picked up by an authorized adult who must present their ID to staff
- Any additions or modifications must be added by written permission

### **Late Pick Up**

Closing hour is 5:00 pm. If you expect to be late, please call the front desk at 714. 573.3009. If you are late picking up your child, a late fee of \$1 per minute is charged starting at 5:01 pm. The late fee is due at the time the child is picked up. **Failure to pay late pick up fees may result in removal from the program. Late pick up can vary per facility. Please see Program Staff for more information.**

**If the child is not picked up by 6:00 pm, staff will contact the Tustin Police Department to pick up your child(ren). The Tustin Police Department phone number is 714. 573.3200.**

### **Daily Activities**

**Supervised Free Play:** Children are given various times for supervised “free play” at the playground.

**Lunch & Snacks:** Please send two (2) snacks and a lunch with your child daily. Most sites do not have room to store lunch or snack items in a refrigerator. Lunch will be provided on special occasions, and parents will be notified in advance.

**Recreation:** Children are encouraged to participate in recreational activities including, but not limited to arts & crafts, cooperative games, educational enrichment, team sports, and special events. If a child does not wish to participate in scheduled activities, they will not be forced to; however, the child must always stay under staff supervision and will be required to participate in an alternate activity.

**Excursions:** An excursion will be scheduled during your camp week. Parents that do not want their children to attend the scheduled field trip must find alternate care for that day. All available staff will be attending the scheduled trips.

Depending on the circumstances, disciplinary problems occurring during excursions may result in the immediate notification of parents for pick-up and loss of privilege to attend excursions and/or camp in the future.

Children are encouraged to bring a “sack” lunch on excursion days so that they do not have to purchase lunch or carry their lunchbox with them for the duration of the day. If your child is going to purchase lunch or souvenirs on an excursion, it is the parent’s responsibility to provide them with the money. Camp staff will have the money in the a

secure place until lunch. Please note that some excursions are cashless.

Children are required to travel to and from excursions with the transportation that we have provided. Parents are discouraged from dropping off/picking up children from the excursion location.

### **Photo Policy**

On occasion, staff or independent photographers of the Parks and Recreation Department may take photographs or videos of participants in our programs, at city parks, or during special events. **If you do not wish for your child to be photographed, please notify the Program Staff for a Photo Waiver.**

### **Disciplinary Rules**

The following rules apply to all participants enrolled in the program:

1. Respect the staff. Listen, be polite, and always inform the staff of problems before/when they occur.
2. Participate in organized activities.
3. Obey all camp rules. No swearing, horseplay, etc.
4. Stay within the designated boundaries. Children must remain within the building and playground areas, unless otherwise supervised. Children who willfully defy this rule will be referred to the Site Lead or Program Coordinator.
5. Keep your hands to yourself. Fighting will not be tolerated.
6. Respect and share camp equipment and materials.

### **Disciplinary Action(s)**

In order to maintain a quality program, it is necessary to inform you of our program goals and discipline procedures.

**Minor Infractions:** This includes pushing, grabbing or lightly kicking another child, verbal arguments, disobeying a leader, and going out of bounds.

1. Verbal Warning
2. Reduction of free time
3. Call to parent/guardian

**Major Infractions:** This includes fighting or aggressive behavior towards other children or staff, kicking, blatant disobedience, foul language or gestures, racial slurs, repeatedly going out of bounds, leaving the premises without permission, use or possession of drugs or alcohol, or damage to property. Consequences may include any one of the following: exclusion from field trips, suspension for a day or more, and/or possible removal from the program.

Parents will be notified by the Program Coordinator when infractions occur. Major infractions will require a conference with the Recreation Supervisor. A conference for repeated infractions will be arranged with the parent/guardian, Program Coordinator, and the Recreation Supervisor before the child is removed from the program.

Please keep in mind that these policies are necessary for us to provide a safe environment for your child(ren). Continual disregard for the policies could result in suspension and/or removal from the program.

### **Serious Infractions**

This includes, but is not limited, to the following:

1. Possession of any firearm, knife, explosive, or other dangerous object considered to be a weapon
2. Intentionally engaging in harassment, threats, or intimidation directed against another child or staff member
3. Stating or implying possession of a weapon, even if, upon review, the statement is determined to be unfounded

There will be an immediate suspension of five (5) days from the program for individuals who, upon review, staff determines have committed a serious infraction listed above. If subsequent violations of (2) or (3) occur, participants could be removed from the program. Committing a serious infraction listed in (1) will be grounds for immediate removal from the program.

### **Accidents**

All accidents that involve your child will be brought to your attention. Staff will provide basic first aid for minor accidents, such as a scratch from a fall, which would require washing the wounds and applying bandages. You will be notified of the actions taken at pick up.

### **Serious Accidents or Illness**

You will be notified immediately if a serious accident occurs which requires medical observation, first aid treatment, or emergency responders. Based on the paramedics' recommendation, children may be transported to the nearest emergency hospital for treatment. If necessary, an ambulance will be called, and a staff member will accompany your child. Depending on the severity, police may be contacted.

### **Safety Precautions**

1. Please drop off and pick up your child at the designated area. For the safety of your child(ren), we do not allow participants to meet their parents outside
2. A staff member must be present when dropping off and picking up your child
3. Bring a form of ID when picking up your child and be prepared to show it to staff upon arrival
4. Bring a written note to the office if someone not listed on your child's form is going to pick up your child
5. If you have a court restraining order or other official documentation that limits someone from picking up your child, please bring a copy to the office

### **Allergies**

All allergies, food, or otherwise, must be reported upon enrollment. Special arrangements should be made and clarified by the parent in writing.

### **Children Who Are Sick**

Children who are ill should remain home. Please call the office if your child will be absent. If your child becomes ill at the center, you will be notified as soon as possible and are required to pick up your child immediately.

## Health Exclusion Policy

<p>Certain symptoms in children may suggest the presence of a communicable disease. Children who have the following symptoms should be excluded from the childcare setting until 1) a physician has certified the symptoms are not associated with an infectious agent or they are no longer a threat to the health of other children at the center, or 2) the symptoms have subsided for 48 hours, or the treatment has started, using the following guidelines.</p>	
<b>If your child develops:</b>	<b>Then keep him/her home until:</b>
<p><b>FEVER -</b> A temperature of 100 Fahrenheit or higher, before fever reducing medication is given.</p>	The fever is normal for 48 hours without fever reducing medication.
<p><b>RESPIRATORY SYMPTOMS -</b> Difficult or rapid breathing or severe coughing that is constant and prevents the child from participating in activities.</p>	Coughing, breathing difficulties and/or other symptoms no longer affect normal activity.
<p><b>VOMITING -</b> Vomited two or more times OR any vomiting if it is accompanied by other symptoms such as fever, behavioral changes, abdominal pain, or diarrhea.</p>	48 hours after vomiting has stopped.
<p><b>DIARRHEA -</b> An increased number of abnormally loose stools in the previous 24 hours. Observe the child for other symptoms.</p>	48 hours after the last loose stool.
<p><b>RASH or SKIN PROBLEMS</b></p>	<p>Rash disappears or is diagnosed as not contagious.                      Impetigo - 48 hours after treatment begins and lesions are dry or can be covered with bandages.                      Scabies - 48 hours after treatment begins.                      Chicken Pox - until blisters have dried into scabs, about 6 - 10 days after onset.                      Ringworm - 48 hours after treatment begins.</p>
<p><b>CONJUNCTIVITIS (Pinkeye) -</b> Tears, redness of eyelid lining, irritation followed by swelling and discharge of pus.</p>	48 hours after treatment begins.
<p><b>HEAD LICE</b></p>	First treatment is completed, no live lice are seen, and you have removed ALL nits (eggs).
<p><b>STREP THROAT / SCARLET FEVER</b></p>	48 hours after treatment begins AND child is without fever.
<p><b>GENERAL LETHARGY -</b> When a child is not able to participate in activities with reasonable comfort and requires more care than the program staff can provide without compromising the health and safety of other children.</p>	Condition improves.
<p><b>HAND-FOOT-AND MOUTH-</b> A mild but highly contagious viral infection common in preschool children. Hand-Foot-and-Mouth disease is characterized by sores in the mouth and a rash on the hands and feet. It spreads from person to person, usually through unwashed hands or contaminated surfaces. The most common cause of Hand-Foot-and-Mouth disease is coxsackievirus infection.  <b>Signs and symptoms</b>                      The signs and symptoms of hand-foot-and-mouth disease include: fever, sore throat, painful red blister-like lesions on the tongue, mouth, palms of the hands or soles of the feet, headache, fatigue and irritability in infants and toddlers.</p>	<p>The usual period from initial infection to the onset of signs and symptoms (incubation period) is three to seven days. Fever is often the first sign of Hand-Foot-and-Mouth disease, followed by a sore throat and sometimes a poor appetite and the feeling of being sick (malaise). One or two days after fever begins, painful sores may develop in the mouth or throat. Rash on the hands and feet can follow within one or two days, and may also appear on the buttocks. Hand-Foot-and-Mouth disease may cause all of the described signs and symptoms, or just a few of them.</p>

# Code of Conduct for Tustin Parks and Recreation Youth Programs

Please review the following Code of Conduct with your child and provide your acknowledgment.

## **General Conduct**

1. **Respect for Others:** Treat all staff, volunteers, and other participants with courtesy, respect, and consideration. Disruptive behavior, abusive language, or harassment of any kind is strictly prohibited. Fighting, bullying, and/or aggressive behavior will not be tolerated.
2. **Cleanliness:** Please help us maintain a clean and welcoming environment by disposing of trash in designated receptacles and keeping spaces tidy. Food and beverages are only permitted in designated areas.
3. **Safety First:** For the safety of all, avoid obstructing walkways and exits. Running, roughhousing, and any hazardous activities are not allowed within the facility. Follow staff instructions and guidelines.
4. **Dress Code:** Be properly clothed at all times. Proper attire consists of a shirt/top, pants/skirt, and closed-toe shoes.

## **Facility Use**

**Noise Levels:** Out of respect for all participants, please keep noise to a minimum in shared areas. Music, presentations, or other amplified sound should be kept at a reasonable volume.

## **Playground Rules**

1. No equipment/toys on the playground structure.
2. No climbing up the slides.
3. One at a time going down the slides.
4. No throwing woodchips or sand.
5. No playing with sticks.
6. No eating on the playground structure.
7. Must wash hands before going out to snack and/or lunch.
8. Must stay within the boundary set by staff members.

## **Restroom Rules**

1. Ask a staff member before going to the restroom.
2. Take a buddy when going to the restroom.
3. When using the restroom, only one person in each stall.
4. Keep restroom clean – do not leave trash on the floor, keep water in the sink, throw trash in proper receptacles.
5. No yelling or playing in the restroom.

6. If the restroom requires attention, please notify Program Staff.

### **Prohibited Items**

1. Bicycles, mopeds, and skateboards are not allowed inside the center. Please use the provided bicycle rack outside of the facility.
2. The possession, use, or distribution of alcohol, weapons, or illegal substances is not permitted on the premises.
3. Panhandling and soliciting is prohibited.
4. Committing or attempting to commit any activity that would constitute a violation of any federal, state, or local criminal statute or ordinance is prohibited.
5. All animals, except service animals, are not allowed within the center.

### **Additional Guidelines**

1. **No Smoking or Vaping:** Smoking and vaping are strictly prohibited within the facility and within 25 feet of all entrances. Follow nonsmoking policies as stated by the Tustin City Code Section 4120 et seq. Smoking and vaping is prohibited for individuals younger than 21 years of age.
2. **Lost Items:** The facility is not responsible for lost or stolen items. Please keep personal belongings secure and within sight. It is recommended to label personal belongings.
3. **Compliance with Staff Requests:** All participants and their families must comply with requests from Program Staff who are authorized to enforce this Code of Conduct to maintain a safe and welcoming environment.
4. **Loitering:** Loitering, lying down, and/or appearing to be sleeping in/around the center is not permitted.
5. **Signage:** Adhere to all posted rules and signs.

### **Violations**

Participants who do not follow the Code of Conduct may be suspended or removed from the program.
