1. All applications are subject to approval.
2. Booths are required to be open and staffed during the entirety of event hours.
3. Each vendor is responsible for sales at their booth. Please make arrangements for adequate change.
4. Vendors can only sell those items listed and approved on the application.
5. Vehicles must follow all traffic regulations (traffic flow, parking, no parking areas, speed on site, etc.).
6. Vehicles in violation of parking regulation(s) will result in vehicle being towed away at owner's expense.
7. Vendors should park on side streets or other public parking locations away from event to allow for shoppers to park closer to the event
8. Vendors must check in at Tustin Civic Center Parking Lot and wait to receive information before proceeding to their assigned booth.
9. Vendors cannot check in before 6:00 a.m. No exceptions.
10. A parking spot is provided for the booth space.
11. No refunds 15 days prior to the event

Check-In Information

1. Event location: Tustin Civic Center Parking Lot, 300 Centennial Way, Tustin, CA 92780.
2. Check-in at the Tustin Civic Center Parking Lot, entering from Centennial Way from 6:00 a.m. to 7:00 a.m.
3. There is a two (2) car maximum for unloading.
4. All vehicles must be off the the parking lot by 7:30 a.m.
5. Food or beverages are **NOT** allowed to be sold at the event.
6. No electrical hookups will be available. Vendors must set up their own booth. No tables, chairs, or canopies will be provided.

City of Tustin Compliance Agreement

I have read and understand the City of Tustin information sheets and guidelines. I agree to abide by the rules as stated. I agree/understand that all promotion of my items must take place within the confines of my booth. I further understand that the City of Tustin and all their representatives are not responsible for or liable for damages, including, but not limited to, loss suffered by me before, during, or after the 2026 Community Yard Sale, or as a result of the display of my work, equipment, or materials. I agree to indemnify the City for any and all damages and losses incurred by me or my agents due to my actions or the actions of my agents, or acts of God. The distribution, duplication, or use of any trademarks or logos belonging to the City of Tustin is strictly prohibited without the express written consent from the City of Tustin. The City of Tustin reserves the right to refuse booth space to any group or organization that does not comply with the rules or regulations of the State, County, and/or the City of Tustin. Certain rules and regulations have been established to protect the rights of participants and public as well. I understand that if these rules are not upheld, my booth will be closed immediately and my fees will not be refunded. The City of Tustin has the sole discretion to exclude any vendor who does not meet the spirit and intent of the Community Yard Sale.
