- All applications are subject to approval.
- Booths must remain open and staffed for the entirety of event hours.
- Each vendor is responsible for handling sales at their booth, including providing adequate change.
- Vendors may only sell the items listed and approved on their application.
- Vehicles must follow all traffic regulations, including traffic flow, parking restrictions, and on-site speed limits.
- Vehicles parked in violation of regulations are subject to towing at the owner's expense.
- Vendors should park in the free public lot at the park or at the Flight parking lot (subject to charge).
- Vendors must check in at Barks Barracks at Tustin Legacy Park and wait to receive instructions before proceeding to their assigned booth.
- No refunds will be issued within 15 days of the event.



CITY OF TUSTIN COMPLIANCE AGREEMENT

I have read and understand the City of Tustin information sheets and guidelines. I agree to abide by the rules as stated. I agree/understand that all promotion of my items must take place within the confines of my booth. I further understand that the City of Tustin and all their representatives are not responsible for or liable for damages, including, but not limited to, loss suffered by me before, during, or after the 2026 Bark Barracks Smooches and Pooches, or as a result of the display of my work, equipment, or materials. I agree to indemnify the City for any and all damages and losses incurred by me or my agents due to my actions or the actions of my agents, or acts of God. The distribution, duplication, or use of any trademarks or logos belonging to the City of Tustin is strictly prohibited without the express written consent from the City of Tustin. The City of Tustin reserves the right to refuse booth space to any group or organization that does not comply with the rules or regulations of the State, County, and/or the City of Tustin. Certain rules and regulations have been established to protect the rights of participants and public as well. I understand that if these rules are not upheld, my booth will be closed immediately and my fees will not be refunded. The City of Tustin has the sole discretion to exclude any vendor who does not meet the spirit and intent of the Smooches and Pooches event.
