

City of Tustin Certificate of Liability Insurance Requirements

The City of Tustin requires a Certificate of Liability Insurance in the amount of one (1) million dollars naming the City of Tustin as Additional Insured. A two (2) million dollar limit is also available upon request and/or need.

IF YOU ALREADY HAVE AN INSURANCE BROKER, PLEASE SUBMIT THE FOLLOWING:

If your Certificate of Liability Insurance and endorsements are not worded correctly, you are responsible for contacting your insurance agent.

Additional Requirements

- Additional Insured Endorsement
- Primary & Non-Contributory Endorsement
- 30-Day Cancellation Endorsement

Please note these are three (3) separate documents and are not included in the Certificate.

Each endorsement must list the policy number and the City of Tustin as the holder under "Person/Organization".
